Goal

A local group of families have learned that the Municipality of East Ferris owns a piece of land on Astor Road that is currently not designated for any specific use.

Our goal is to have this land developed into a park with a playground for families to enjoy.











Overview of East Ferris

According to the 2016 Census, **nearly half** of family households in East Ferris have children (Table 1).

Additionally, the age distribution shows that 15.5% of the population is under the age of 15 (Table 2). Of these children, 60% are under the age of 10 (Table 3), making a playground an ideal recreational option for a significant portion of our community.




School Playground Limitations

Paul Manning, NNDSB Facilities/Capital Planning Administrator, has indicated that "Technically, you are not approved to be on the school site using the equipment as it becomes a liability issue for the Board". (Appendix A)

This leaves only <u>one</u> accessible playground for families to utilize in the East Ferris Community (Bill Vrebosch Park).

The Municipal property on Astor Street South consists of two parcels of land totaling 1.15 acres

- •Parcel 1 = .08 acres
- Parcel 2 = .34 acres

Community Engagement Survey


82 East Ferris families and community members took part in our community feedback survey between October 24th – November 30, 2024

Q1 Which community in East Ferris do you reside in?



Q3 Do you have children living in your household?



Average age of children in our community based on those who completed the survey.



Q6 How important do you think it is to have a playground in your community?



Q7 Do you feel that East Ferris currently has enough recreational spaces for children?


