6.1 Council Resolution 2021-326 - Return to in person meetings

AND WHEREAS the Economic Development Committee feels a hybrid model allowing for both virtual and in-person attendance at meetings would respect each committee members comfort levels with regards to COVID19.

THEREFORE BE IT RESOLVED that the Economic Development Committee recommends Council allow the Economic Development Committee to adopt a hybrid model for their quarterly meetings.

6.2 2022 Tradeshow

7. Action Items:

7.1 Farmstand Tour Follow Up 7.1.1 Next Steps

The Farm Stand Tour was a success. Mr. Kirton thanked Chair Lacourse for all his work. Chair Lacourse will give administrative control of the Facebook page to the Municipality of East Ferris, as per the East Ferris Social Media Policy, for long term operation. The Committee discussed winter content for the spring season and mapping.

The Committee discussed using the farmstand tour page as a way to gauge additional interest for the postponed farmer's market project.

7.2 Short Term Rental Policy 7.2.1 Zoning By-law Prohibition

The Committee discussed Short Term Rentals in East Ferris. Short Term Rental have dominated the conversation at the two meetings that have already taken place regarding the Zoning By-law. The main issues are with owners that have no intention of living at the property and rent out fulltime, which causes disruptions to the neighbourhood. A licensing fee structure with rules and regulations would make it easier to fine those in violation and create a clear set of requirements and expectations.

WHEREAS the Municipality is in the process of adopting a new Comprehensive Zoning By-law



AND WHEREAS Short Term Rentals are currently prohibited and would be prohibited in the new by-law unless authorized by a zoning by-law amendment

AND WHEREAS Short Term Rentals were discussed in length at both the Open House on October 27th and the Planning Advisory Committee meeting on November 3rd, 2021 and are a point of concerns for residents

THEREFORE BE IT RESOLVED that the Economic Development Committee recommend to Council that the Planning Advisory Committee consider a permitting structure including licensing fees for Short Term Rentals in the new Comprehensive Zoning By-law rather than an outright prohibition without any other policies.

7.5 Winter Quarter Project

7.5.1 Snowmobile Trail Activity

There are still challenges connecting a route from Lake Nosbonsing through Astorville with the inability to get permission from all landowners for trail crossings, but other routes are being explored.



7.5.2 Christmas Market Request

A request for a Christmas Market/Craft show in East Ferris was received. Due to timing, this item will be brought back to the Committee in the fall of 2022.

7.6 East Ferris Vaccination Policy

This item was carried over from the October meeting that quorum was not present for. Committee members were already made aware of the policy.

7.7 East Ferris Economic Development Strategy

7.7.1 Proposal to hire a consultant rather than complete at the committee level

Mr. Kirton suggests the Municipality hire a consultant to update the Economic Development Strategy as opposed to the Committee doing the update. The Committee would review the document for comments. The Committee did not object to Mr. Kirton's suggestion.
