



Thank you for the opportunity to comment on the above proposed severance.

I support the application, as residential development is a good thing for the municipality.

What would be nice is to see the municipality of East Ferris invest some of this new tax revenue into the infrastructure that supports this development. Quae Quae Rd is a busy well used road. Its designation as a Voyageur Cycling Route could be renamed **Voyageur Dump Truck Route**. The large number of heavy vehicles and other speeding vehicles makes pedestrian traffic on the road increasing dangerous, it's not uncommon to head for the ditch when two vehicles meet on the road.

In addition the road is showing wear and tear from all this traffic. The Hurtubise and Corbeil Rd intersections are patched potholes requiring some engineering and proper repaving.

Posted speed limits are not enforced and most drivers know it. Some drivers travel at ridiculous speeds....because they can. Some 'share the road' signs would help remind motorists that the road is also used by cyclists and pedestrians.

A 'no littering' bylaw would be helpful in reducing the garbage and trash on the side of the road and in the ditches. I've commented on this before and offered my assistance but the CAO doesn't respond to letters or return telephone calls.

I take pride in this community and do want to see it grow as a residential and vacation destination. What I don't care for is being ignored when all I want is to make East Ferris a better community.
