- a) **Update Community Safety:** The Plan is on-going and the committee is meeting again on October 8th to continue. It is anticipated that the plan will be ready for January 2021, even though the deadline date has been changed, we have not heard about a new date as of this time.
- b) **Plan Speeding Enforcement:** An important component of our CSWB Plan will be speeding. We have many individuals that walk, bike and we have been receiving complaints from residents regarding the speeding. Chair advised that a resolution was being prepared for Council for their meeting of September 22nd, 2020. OPP advised that when we receive complaints we need to get as much details as possible, such as time of day, hot spots. At this time the OPP are focused on the buses. OPP will contact MTO and inquire if they have a breakdown of the speeding tickets pertaining to East Ferris
- c) **Active Transportation:** Increase the width of roads, strat plan, best practices
- d) **Updates to Permitted Off-road Vehicles and Three-wheeled Motorcycle Licensing:** The Municipal By-law No. 2015-29 was brought to the attention of the OPP. The PSB is aware of the added vehicles to the Ont. Regulation 316/03. OPP advised that our by-law is OK as we have the paragraph in our by-law for amendments. By-law No. 2015-29 reads: "*That the operation of off-road vehicles, meaning, an all-terrain vehicle, a multi- purpose off –highway utility vehicle or a recreational off-highway vehicle shall be permitted on any highway within the Municipality of East Ferris under the jurisdiction of the Municipality of East Ferris in accordance with O. Reg 316/03 of the Highway Traffic Act and any amendments thereto.*"
