11. Other Business

a) East Ferris Parks Commemorative Program

- i) Mrs. Dianne Armatage was welcomed to the meeting. Mrs. Armatage spoke to her wish to donate a bench to be installed at MacPherson Park. Council, at its meeting of July 9th, referred the donation request to the Parks, Recreation and Culture Committee to determine the type of bench and location of its placement. Mrs. Armatage was pleased with the thought of a formal donation program similar to that of the Memorial Park Commemorative Program.
- ii) The Committee agreed that a program to ensure consistency of donations across parks in East Ferris was a good idea and made the following recommendation to Council:

WHEREAS Council referred this request to the Parks, Recreation & Culture Committee for finalization of the model and installation.

THEREFORE be it resolved that the Parks, Recreation & Culture Committee recommends to Council that a formal donation policy be created for clarity and uniformity, similar to that of the Memorial Park Commemorative Program and further that staff work with the Committee to finalize and implement this program.

b) Events Calander

i.) Review and follow-up from April 16th meeting

The Committee continued their review of the Events Calander. It was noted that an in-person Canada Day event should be the focus for 2025. The Committee discussed the requirement of an increased event budget for next year. Committee members will brainstorm possible activities and bring their ideas forward to a future meeting.

c) Activity Matching

Chair Rochefort spoke to the impressive amount of activity related equipment at the East Ferris Public Library, including tennis and pickleball rackets, walking sticks, pedometers, etc. Chair Rochefort also noted that there has been an expressed interest by residents for a volunteer-led walking club. Collaboration opportunities were discussed.

Program Coordinator Jenna Cowden noted that there has also been inquiries to an indoor walking program at the East Ferris Community Centre. Jenna will continue to work with various groups in an effort to support active programming at the Community Centre. Representatives from these groups will be invited to the next Committee meeting.

The Committee discussed potential clinics for youth utilizing the equipment at the Library. Staff was asked to conduct research on offering tennis clinics to youth, and to bring their findings to the next meeting.

These items will be brought forward for further discussion at the next meeting. In the meantime, Staff will increase the promotion of this equipment by sharing the Library's posts on our social media page.



d) Participaction

The Committee discussed the efforts that have been made with the ParticipACTION program over the last number of years. It was agreed upon that we continue to monitor the program next year for potential funding opportunities.

e) Updates

The Director of Community Services advised that the new playground at the Corbeil Recreation Hub is now complete. We are receiving positive feedback, and the play structure appears to be busy with youth utilizing the new equipment. Chair Rochefort congratulated staff, on behalf of Council, for their efforts.
