Good afternoon Monica,

Thank you for taking my call earlier. As discussed, on behalf of the MTO, AECOM is planning the rehabilitation of Highway 94 from Terrace Road (South Junction), northerly to 260 m north of Highway 94 / Lansdowne Street / Callander Bay Drive intersection.

This project includes the removal of the Highway 94 CNR Overhead Callander South Bridge. The location of this structure is shown on the attached map. Given the significant construction-related constraints associated with the design of the existing structure, a Full Road Closure using a 24-hour continuous operation is planned to facilitate its removal. Work is expected to take one week, and the 24-hr operation will continue until the highway is fully restored. As I mentioned, detour options are

available, the OPP has been advised, and the Municipality of Callander has issued a Council Resolution in support of this work.

The closure is currently proposed to take place from August 19 to August 23, 2019. This timeframe was selected to minimize impacts for school busses, long weekends and local events. Several other measures will be put in place to help mitigate the impact of the closure including advanced signage, advance telephone and letter notification of stakeholders, newspaper notices and radio announcements, and emergency services and OPP will be specifically notified.

We wanted to inform you of this project and planned closure given the proximity to the Municipality of East Ferris. Please feel free to contact me if you have any questions, or would like additional information.
