AND TAKE NOTICE that the Municipality of East Ferris Planning Advisory Committee will hold a Public Meeting on **Wednesday, April 16, 2025** at 5:00 p.m., to consider the proposed application and make a recommendation to council. A Public Meeting is being held pursuant to Section 34(12) of the *Planning Act*. **COUNCIL** will make a decision on the application on **April 22, 2025** at 5:00 p.m. at the regular meeting of council.

EXPLANATORY NOTE

The Municipality of East Ferris is proposing to amend the Municipality's Comprehensive Zoning By-law No. 2021-60, as amended. The proposed amendment is to rezone the subject parcel of land from the existing Rural (R) zoning to a Institutional (I) Special zoning in order to permit the construction of a new Municipal Fire Hall.

PURPOSE AND EFFECT

The purpose of the proposed By-law is to rezone the subject lands from the Rural (R) zone to the Institutional (I) Special zoning in order to permit the construction of a new Municipal Fire Hall.

ANY PERSON may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposed Zoning By-law Amendment.

IF A PERSON OR PUBLIC BODY does not make oral submissions at a Public Meeting or make written submissions to The Municipality of East Ferris Council before the By-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of East Ferris to the Ontario Land Tribunal (OLT) unless, in the opinion of the OLT, there are reasonable grounds to do so.

IF YOU WISH TO BE NOTIFIED of the decision of the Council of the Municipality of East Ferris in respect to the proposed By-law, you must make a written request to the Clerk of the Municipality.
