Subject: Dawber Land Purchase Request

RECOMMENDATION

1. That the application from Tanya Dawber (owner of 62 Kyle Road) to purchase municipal surplus lands on Kyle Road (Part of Lot 9, Con 3, Plan 36R6186, Parts 1 and 2, Parcel 15895) be approved and disposed of in accordance with the policies of By-law 2218. This parcel of land was deemed surplus by Council on September 12, 2017.

BACKGROUND

The Municipality of East Ferris owns a parcel of land on Kyle Road that is 0.61 acres in lot area. Kyle Road is a private road that does not run along a municipally owned road allowance. Kyle Road crosses a part of this property owned by the municipality but would be considered a forced road rather than a road along a municipal road allowance. **Schedule A** and **Schedule B** show the property location.

On September 12, 2017, Council approved a request to deem this land surplus and allow an application to be made to purchase the land. The land was deemed surplus by resolution 2017-306.

Almost every property between 62 Kyle Road and 150 Kyle Road have lands on both sides of the road with Kyle Road running through the middle. The applicant's request to purchase the surplus municipal land would result in the same scenario as these properties and would allow for the use of the opposite side of the road for the construction of a garage and storage, similar to other adjacent properties.

The municipal land that is subject to this application is land locked from any public road allowance or any other municipally owned land and has very little value to the municipality for operational purposes or future infrastructure.

OPTIONS

1. Option 1

That the application from Tanya Dawber (owner of 62 Kyle Road) to purchase municipal surplus lands on Kyle Road (Part of Lot 9, Con 3, Plan 36R6186, Parts 1 and 2, Parcel 15895) be approved and disposed of in accordance with the policies of By-law 2218. This parcel of land was deemed surplus by Council on September 12, 2017.

2. Option 2

That the application from Tanya Dawber (owner of 62 Kyle Road) to purchase municipal surplus lands on Kyle Road not be approved. This would result in the closure of the file and no further action would be taken with regards to this land.


FINANCIAL IMPLICATIONS

The municipality would be able to generate a small amount of revenue from the sale of a piece of land that has little functional use for municipal operations.



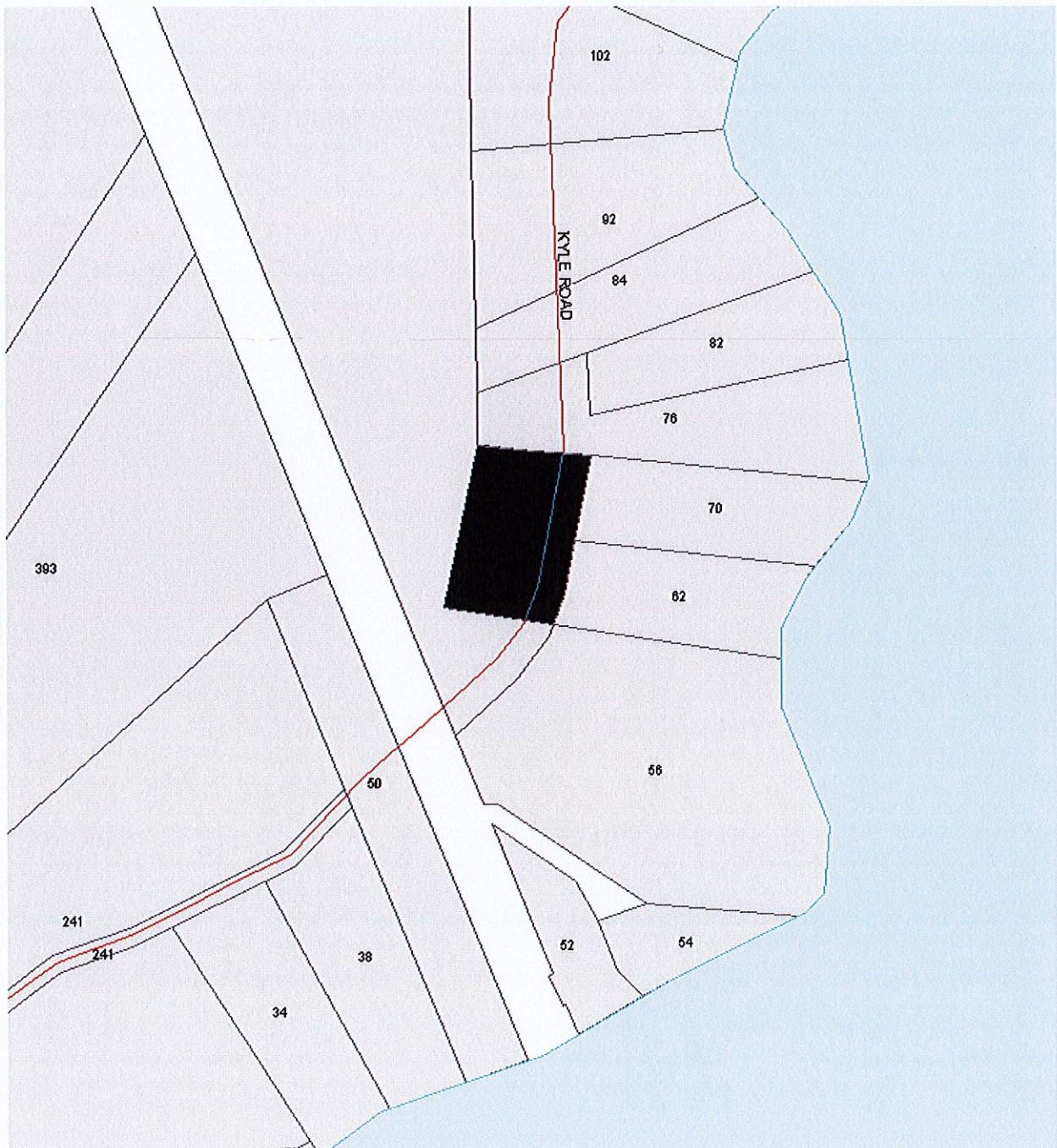
